- **Type(s) of food with which the product is intended to be put in contact:**
 - Clear drinks (Water, ciders, clear fruit or vegetable juices of normal strength or concentrated, fruit nectars, lemonades, syrups, bitters, infusions, coffee, tea, beers, soft drinks, energy drinks and the like, flavored water, liquid coffee extract);
 - Cloudy drinks (Juices and nectars and soft drinks containing fruit pulp, musts containing fruit pulp, liquid chocolate.)
 - Milk and milk based drinks whole, partly dried and skimmed or partly skimmed
- **Time and temperature and storage while in contact with food:**
 - 70 °C for up to 2 hours;
 - or 100 °C for up to 15 minutes
- **The ratio of food contact surface area to volume used to establish the compliance of the product**

The compliance testing was done under conditions set out in Regulation (EU) No. 10/2011 using a surface to volume s/v contact ratio of 2.46 dm²/ 380g (Body) and 2.28dm²/ 250g (Lid).
